

# TERRACE V AT HERITAGE COVE ASSOCIATION, INC.

## FREQUENTLY ASKED QUESTIONS AND ANSWERS SHEET AS OF **JANUARY 1, 2019**

**Q: What are my voting rights in the Condominium Association?**

A: There are 30 units in Terrace V at Heritage Cove Association, Inc. and the owner of each unit has one indivisible vote which may be cast in all matters which require a vote of the owners. Voting rights and procedures are described in Section 2 of the Bylaws of the Association.

**Q: What restrictions exist in the Condominium Documents on my right to use my unit?**

A: Each unit is restricted to residential single-family use. The owner of each unit may keep no more than two (2) small pets, of a normal domesticated household type (such as a cat or dog) in the unit. Dogs and cats must be leashed or carried at all times while outside of the unit. The ability to keep pets is a privilege, not a right, and the Board of Directors may order and enforce the removal of any pet which becomes a reasonable source of annoyance to other residents. The owner is responsible for cleaning up after his pet. No pets of any kind are permitted in leased units. No reptiles, rodents, poultry, amphibians, swine or livestock may be kept in the Condominium, but tropical fish or caged birds in reasonable numbers are permitted. The restrictions on unit use are found in Section 12 of the Declaration of Condominium.

**Q: What restrictions exist in the Condominium Documents on the leasing of my unit?**

A: Written notice in advance to the Association of all leases is required. The minimum lease term is 30 days. The maximum number of overnight occupants of a leased unit is 6 persons, and no pets are allowed in leased units. Other leasing restrictions are found in Section 13 of the Declaration of Condominium.

**Q: How much are my assessments to the Condominium Association for my unit type and when are they due?**

A: Quarterly assessments based on the Association's annual budget are due on the first day of January, April, July and October. The assessments are **\$800.00** per quarter for **2019**.

**Q: Do I have to be a member in any other Association? If so, what is the name of the Association and what are my voting rights in this Association? Also, how much is my assessment?**

A: Each unit owner is required to be a member of Heritage Cove Community Association, Inc. Each unit owner has one vote in the Community Association's affairs, but all the votes of unit owners in this Association are cast by the Association's Voting Representative. The annual assessment is payable by each unit owner directly to Heritage Cove Community Association in the amount of **\$2,232.00** for calendar year **2019** and is due on the first day of **January 2019**.

**Q: Am I required to pay rent or land use fees for recreational or other commonly used facilities? If so how much am I obligated to pay annually?**
